



Flex System 3X Power Cord

The Lenovo Flex System 3X power cord can be used with a Lenovo Flex System Enterprise Chassis to connect three chassis power supplies to a single power source. The power cord is approximately 4.3 meters (14 feet) in length and has three C19 power supply connectors with three cable lengths. Refer to the table below for the description and option number for the power cord designated for use in your country or region.

Note: If the power source is located below the chassis, connect the longest power supply connector cable to the power supply that is located closest to the top of the chassis. If the power source is located above the chassis, connect the longest power supply connector cable to the power supply that is located closest to the bottom of the chassis.

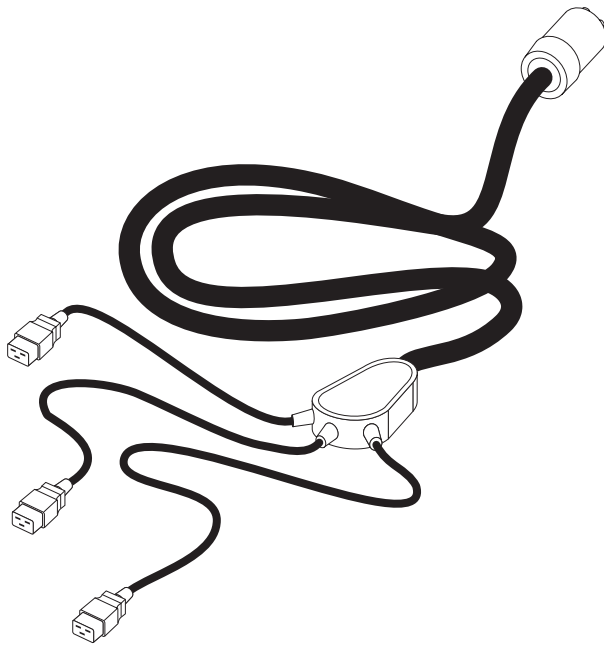
