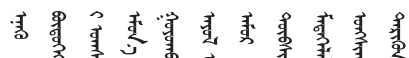

# Chapter 1. IBM Flex System CN4054 / CN4054R 10Gb Virtual Fabric Adapter

The IBM Flex System™ CN4054 / CN4054R 10Gb Virtual Fabric Adapter is a converged network adapter (CNA) that is designed for use in IBM X-Architecture® compute nodes.

This *User's Guide* contains information and instructions for functionally installing the adapter, updating the firmware, and solving problems. See the documentation that came with your IBM Flex System compute node for information on how to physically install the adapter. Return to this *User's Guide* for information and instructions needed to complete the functional installation.

## Features and specifications

The CN4054 / CN4054R 10Gb Virtual Fabric adapter has the following features and specifications:

- Four-port 10GB Ethernet adapter with two operational mode choices:
  - Four-port Physical Mode, pNIC, Multichannel disabled, or
  - The default Virtual NIC Mode, vNIC, Multichannel enabled; vNIC mode provides four vNICs per physical port for a total of 16 vNICs.
- Establishing active links in vNIC mode requires some configuration on the connecting I/O modules. Until configured, the vNIC links will be in a Link Down state.
- The adapter supports two options for vNIC linking:
  - vNIC1, IBM Virtual Fabric Mode, which is the default option, or
  - vNIC2, Switch Independent Mode, which can be selected in Setup.
- The following list is a basic list of the features the adapter supports.
  - Link Auto negotiation 10 Gb/1 Gb Full duplex
  - Bus-mastering support
  - Direct memory access (DMA) support
  - Uses standard Emulex® SLI drivers
  - Interoperates with existing FC SAN infrastructures – switches, arrays, SRM tools (including Emulex utilities), SAN practices, and so forth
  - Unified Ethernet-to-FC SAN connectivity provided by an FCoE switch
  - Provides 10 Gb MAC features such as MSI-X support, jumbo frames (8k bytes) support, VLAN tagging (802.1Q, PER priority pause/priority flow control), and advanced packet filtering
  - No host operating system changes are required. NIC and HBA functionality (including device management, utilities, and so forth) are transparent to the host operating system.
  - NIC failover support
  - Integrated Open Fabric Manager (IOFM) support
  - Preboot Execution Environment, UEFI and Legacy PXE
  - WoL (Wake on LAN) on all ports
  - SRIOV support
  - iSCSI or FCoE capabilities may be enabled via FoD (IBM Feature on Demand)
  - Onboard thermal monitoring and control
  - LED fault light support
  - Compliance with U.S. and international safety and emissions standards
- The adapter is constructed with two dual port NICs, Network Interface Controllers, or ASICs. The first port of each ASIC connects in parallel to one I/O Module bay, and the second port of each ASIC connects in parallel to a second I/O bay.

- 
- If the adapter is installed in the MEZZ-1 position of the server, the I/O bays are #1 and #2.
  - If the adapter is installed in the MEZZ-2 position of the server, the I/O bays are #3 and #4.
  - The adapter is manufactured with 16 burned in MAC addresses.
  - If an adapter is in pNIC mode without storage configured, each port uses two MAC addresses. One MAC address is used for normal Ethernet traffic, while a second MAC address is used for LLDP traffic. If the adapter is put into vNIC mode, or if storage is enabled, then more than two MAC addresses will be used on each port.
  - When enabled via FoD, the ISCSI or FCoE operations are supported on the second vNIC of each physical port, or in Physical pNIC mode the functions are across all four ports.
  - Separate NIC, ISCSI, and FCoE drivers are provided to support all configurations.
  - A full complement of Emulex OneCommand™ Manager tools and applications are available to support the operation of this adapter.

## Chapter 4. Solving problems

If you cannot locate and correct a problem by using the information in this section, see Appendix A, “Getting help and technical assistance,” on page 11.

### Running POST

To ensure that it is fully operational, the adapter processes a series of tests during power-up or a restart (power-on self-test, or POST). These tests take approximately 1 minute to complete. The management module reads the test results and displays them for you. During normal operation, these tests are completed without error, and the green OK LED is lit. However, if the adapter fails POST, the amber adapter error LED and the system-error LED on the chassis are lit.

### Parts listing

Replaceable components are of three types:

- **Tier 1 customer replaceable unit (CRU):** Replacement of Tier 1 CRUs is your responsibility. If IBM installs a Tier 1 CRU at your request, you will be charged for the installation.
- **Tier 2 customer replaceable unit (CRU):** You may install a Tier 2 CRU yourself or request IBM to install it, at no additional charge, under the type of warranty service that is designated for your server.
- **Field replaceable unit (FRU):** FRUs must be installed only by trained service technicians.
